*** Other Students” Definition:** A student is anyone enrolled full time in an accredited professional nursing, allied health, paramedic, AA, or other health related program, (ie an undergrad), who is not licensed to practice in their profession or if they are licensed to practice is not working in their area of practice. Fellows must register in the “Fellow” category. Residents/Trainees register in the “Resident” category.

**** Non-Member Rates-** The non-member rate will include a TAC membership (except for the ITNC/TRISC event).

*****Group Rates:** A “group” is a maximum of 50 people in the same category above, (either member or non-members) who are registered from a designated Organization, Hospital or Program who make one (1) group payment. The group “leader” will manage their group by providing each of the 50 registrants with a discount code that will be issued by X-CD. The registrants will then enter their own registration information using the code provided.

******Low/Middle Income Country Rates:** An individual who registers from a mailing address within the countries designated by the 2021 *World Bank List of Economies* as “low income/lower middle income/upper middle income” country list will not be charged a registration fee.
